According to the special resolution passed in the Extraordinary General Meeting held on 19th May 2011, as all the conditions precedent for the implementation of the Capital Reduction have been fulfilled, the Capital Reduction have become effective on 6 July 2011 as followings:-

- (1) the paid-up capital of each issued Consolidated Share be reduced from HK\$0.25 to HK\$0.01 by cancelling HK\$0.24 on each of the issued Consolidated Shares such that the nominal value of each issued Consolidated Share be reduced from HK\$0.25 to HK\$0.01 so as to form a new share with nominal value of HK\$0.01 each (the “**Adjusted Shares**”) (the “**Capital Reduction**”).
- (2) each of the authorised but unissued Consolidated Shares of HK\$0.25 each, including the authorised unissued shares of HK\$0.25 each resulting arising out of the Capital Reduction, be sub-divided into 25 new Adjusted Shares of HK\$0.01 each (such that the authorised share capital of the Company become HK\$150,000,000 divided into 15,000,000,000 Adjusted Shares of HK\$0.01 each).
