COMPLETION OF SUBSCRIPTION OF THE FOURTH BATCH OF CONVERTIBLE BONDS UNDER SPECIFIC MANDATE

Reference is made to the announcements of Finet Group Limited (the “**Company**”) dated 27 July 2015, 4 September 2015, 8 September 2015, and 29 September 2015, 27 November 2015, 23 December 2015 and 6 May 2016 (the “**Announcements**”) and the circular of the Company dated 14 October 2015 (the “**Circular**”) in relation to, among other things, the Subscription of the Convertible Bonds in the aggregate principal amount of HK\$69,696,000 in four separate batches of HK\$17,424,000 each. Unless otherwise stated, terms used in this announcement shall have the same meanings as defined in the Circular.

COMPLETION OF SUBSCRIPTION OF THE FOURTH BATCH OF CONVERTIBLE BONDS UNDER SPECIFIC MANDATE

The Board is pleased to announce that all the conditions precedent as set out in the Subscription Agreement had been fulfilled and the completion of the subscription of the Fourth Batch CB took place on 12 May 2016.

The Fourth Batch CB in the principal amount of HK\$17,424,000 has been issued to the Subscriber at the issue price of 100% of the principal amount. Upon full exercise of the conversion rights attaching to the Fourth Batch CB at the initial conversion price of HK\$0.396 per Conversion Share, a total of 44,000,000 Conversion Shares will be allotted and issued, representing (i) approximately 9.45% of the total issued share capital of the Company as at the date of this announcement; and (ii) approximately 8.64% of the total issued share capital of the Company as enlarged by the allotment and issue of the Conversion Shares upon full exercise of the conversion rights attaching to the Fourth Batch CB (assuming there being no other changes in the share capital of the Company). The aggregate net proceeds from the subscription of the Fourth Batch CB is approximately HK\$17,424,000.

Pursuant to the Subscription Agreement, the completion of the subscription of the Fourth Batch CB was scheduled to take place on or before 23 March 2016.
