PROFIT ALERT
SUBSTANTIAL REDUCTION IN LOSSES

This announcement is made by Finet Group Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571, Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Director(s)**”) of the Company is pleased to inform the shareholders and potential investors of the Company that, based on the preliminary assessment of the unaudited consolidated financial statements of the Group for the six months ended 30 September 2025 (the “**Reporting Period**”) and the information currently available to the Board, the Group is expected to record a profit attributable to owners of the Company of not more than HK\$2.0 million for the Reporting Period, as compared with the loss attributable to owners of the Company of approximately HK\$4.3 million for the six months ended 30 September 2024. The Board believes the Group’s significant improvement in the financial results during the Reporting Period was mainly attributable to the net effect of, among other things, (i) increase in revenue represented increased by approximately HK\$3.7 million or 88% from approximately HK\$4.2 million for the six months ended 30 September 2024 to approximately HK\$7.9 million for the six months ended 30 September 2025 mainly due to a significant increase in revenue generated from the Group’s financial information, advertising and investor relationship service business; and (ii) increase in other income, includes rental concessions more than HK\$0.4 million and write back of over 7 years accounts payable now no longer necessary approximately HK\$1.2 million during the Reporting Period.

As at the date of this announcement, the Company is still in the course of preparing and finalising its unaudited interim results of the Group for the Reporting Period. The information contained herein constitutes a preliminary assessment made by the Board based on currently available information, including the Group's unaudited consolidated financial statements for the Reporting Period. These financial statements have not been reviewed or audited by the Company's auditors nor reviewed by the audit committee of the Company. The actual unaudited interim results of the Group for the Reporting Period may be subject to adjustment based on further updated information and may differ from the information disclosed herein. The shareholders and potential investors of the Company shall refer to the preliminary announcement of the unaudited interim results of the Group for the Reporting Period, which is expected to be published on or around 28 November 2025.

The shareholders and potential investors of the Company are advised to exercise caution when dealing in the shares of the Company.
