UNAUDITED SALES VOLUME IN JANUARY 2017

The board of directors of Geely Automobile Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) is pleased to announce that the total sales volume of the Group for the month of January 2017 was 102,653 units, an increase of approximately 71% over the same period last year, and achieving over 10% of the Group’s full year sales volume target of 1,000,000 units in 2017. The Group’s exports volume was 994 units in January 2017, down around 51% from the same period last year. Despite less number of working days in the month of January 2017 due to Chinese New Year holiday in late January 2017, the Group’s total sales volume in China market still maintained at high level of 101,659 units during the month, an increase of around 75% from the same period last year.

During the month of January 2017, the sales volume of “New Emgrand” was 26,314 units, an increase of about 17% from the same period last year. The sales volume of “Vision” sedan was 14,716 units in the month of January 2017, about the same level in the same period last year. The Group’s “Geely GC9” (吉利博瑞), its B-segment sedan model, achieved a sales volume of 4,042 units in the month of January 2017, down around 33% from the same period last year. During the month of January 2017, the sales volumes of all the Group’s four new models launched in 2016 stayed at their record high levels. The “Geely Boyue” (吉利博越) recorded a sales volume of 20,147 units. The “Emgrand GS” (帝豪GS), its first crossover SUV model, recorded a sales volume of 10,333 units. The “Vision SUV” (遠景SUV), its newest SUV model, recorded a sales volume of 10,226 units. The “Emgrand GL” (帝豪GL), its new generation of A+ segment sedan model, recorded a sales volume of 10,208 units.

Please note that the sales volumes above are unaudited figures and have not been confirmed by the Company's auditors and may be subject to adjustment and final confirmation. Shareholders and potential investors are advised to read carefully the financial results of the Group when it is published.
